Our Environmental Policy and programs use, as a guideline, the United Nations Sustainable Development Goals (“UN SDGs”). Our environmental stewardship programs and practices focus on the following:

- integrating the consideration of environmental concerns and effects into our decision making and activities,
- employing the principles of reducing, reusing and recycling as much as possible,
- minimizing energy and water usage by our hotel properties and corporate offices in order to conserve natural resources,
- improving energy efficiencies in our building design and construction and employing energy conservation best practices in our hotel properties,
- purchasing products and services that do the least damage to the environment,
- training, educating and informing our employees about environmental issues that may affect their work,
- promoting environmental awareness among our employees and encouraging them to work in an environmentally responsible manner,
- communicating our environmental commitment to our guests, business partners, other stakeholders and the public and encouraging them to support it,
- reducing energy costs through environmental controls, and
- identifying opportunities in new and innovative programs offered through utility companies and with local, state and national agencies.

We continuously build upon our culture of environmental stewardship by raising awareness through training and other programs.
